

# GOLDEN TICKET

## Free Prize Draw Terms & Conditions

1. The Golden Ticket prize draw (the "Prize Draw") is open to anyone who successfully booked / books a track session on the new Velodrome Track at HSBC UK National Cycling Centre for attendance between qualifying dates.
2. The qualifying dates for a new track session booking to be entered into the Prize Draw runs inclusively from 08:00 Monday 28 May through to 22:00 Sunday 2 September 2018.
3. Employees or agencies of HSBC UK National Cycling Centre / Eastlands Trust and or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
4. To enter the Prize Draw you must have successfully booked a track session to ride the new Velodrome Track during the qualifying period (see pt.2). 5. One entry per booking. Any additional or multiple bookings to ride the track during the qualifying period will be valid and submitted as an entry. Bookings on behalf of another person will not be accepted as a valid entry.
6. HSBC UK National Cycling Centre accepts no responsibility for bookings that are delayed or incomplete or cannot be entered for any technical or other reason.
7. The closing date of the Prize Draw is 21:59 20 May 2018. Any current bookings made from 2 January 2018 to ride the track during the qualifying period (see pt.2) will also be included into the Prize Draw. Any entries (bookings) to ride the track outside the qualifying time period (from 3 September 2018 onwards) will not be considered.
8. Fifteen (15) winners will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by an independent and random process. The draw will take place on Monday 21 May 2018.

9. Prize include: 1 x 1 hour track taster session (10 - 11am Monday 28 May 2018). The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes. HSBC UK National Cycling Centre retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available.
10. HSBC UK National Cycling Centre accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from).

11. The winners will be contacted by phone on Monday 21 May 2018. If a winner does not answer on the day, then the winner's prize / place will be forfeited and we are entitled to select another winner in accordance with the process described above (and that winner will have to respond on the same day or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and we shall be entitled to select another winner.
